**Mr Nelson Chow**

**Chief Fintech Officer, Hong Kong Monetary Authority**

Mr Nelson Chow has been appointed Chief Fintech Officer from 1 September 2016 with responsibilities for facilitating the healthy development of the Fintech ecosystem in Hong Kong and promoting Hong Kong as a Fintech hub in Asia. He joined the Hong Kong Monetary Authority (HKMA) in 2004 and was responsible for the supervision of banks' technology risk management and business continuity planning as well as the formulation of related policies and guidelines. He was the Deputy Chief Representative of the New York Office in 2010. After returning to Hong Kong in 2013, he took up responsibilities to supervise banks' operational risk management and perform macro-prudential data analysis. Prior to joining the HKMA, Nelson was a Vice President of JP Morgan Chase Bank, N.A. responsible for information risk management of the Asia Pacific region.
