於二零零九年五月初,一家主要從事汽車保險業務的本地保險公司被頒令臨時清盤。該保險公司的大部份保險申索,關乎汽車第三者人身傷亡及汽車第三者財物損毀,已由香港汽車保險局管理的無償債能力基金接手處理。在此情況下,該保險公司的索償數據自二零零九年第二季起並不包含於有關統計數字中。因此,以上報表列載的汽車直接業務的承保業績未能充份反映整體市場的實際情況,尤其是貨車及的士。於二零一零年七月十九日,法院已頒令該保險公司進行清盤。

A local insurer which engaged primarily in motor vehicle insurance business was placed into provisional liquidation in early May 2009. The bulk of the insurance claims made against the insurer, being in respect of Motor Vehicle Third Party Bodily Injury and Motor Vehicle Third Party Property Damage, have been taken up by the Insolvency Fund administered by the Motor Insurers' Bureau of Hong Kong. Under these circumstances, the claims figures of the insurer have not been incorporated in the relevant statistical data since the second quarter of 2009. Hence, the underwriting result for Motor Vehicle direct business shown in the table above, especially that for Goods Carrying Vehicles and Taxis, cannot fully represent the overall industry performance. The insurer has been placed into liquidation by order of the court on 19 July 2010.
