United Nations (Anti-Terrorism Measures) Ordinance ("Ordinance"), United Nations Sanctions (Afghanistan) Regulation ("Regulation") & United States Executive Order 13224 ("Executive Order")

Further to my letter of 24 November 2004, I am writing to advise you that an updated list of names designated by the relevant United Nations Security Council Committee was published in the Gazette (G.N. 314 and G.N. 420) on 21 January 2005 and 28 January 2005 in accordance with the Ordinance and the Regulation respectively. The new list is available on the Government website (www.gld.gov.hk/egazette/) under Gazette: Government Notice published on 21 January 2005 and 28 January 2005. To facilitate the update of your electronic database, a copy of the list in MS Word format is also available on the Insurance Authority's website (http://www.info.gov.hk/oci/framework/index04.htm).

Compared with the names advised in my letter of 24 November 2004, the following changes have been made:-

The information can be found in the website of the Office of Foreign Assets Control of the US Treasury (www.ustreas.gov/offices/eotffc/ofac/sanctions/terrorism.html) under the heading of "Name of Individual Designated on 25 January 2005".

You should review your records carefully to see whether you have had, or currently have, accounts, transactions or dealings with the named individuals or entities. If such review reveals any suspicious accounts, transactions or dealings, you should promptly notify the Joint Financial Intelligence Unit.
