Seminar on Prevention of Money Laundering

The Insurance Authority ("IA") is committed to the prevention of money laundering activities in the insurance industry. In order to achieve this objective and keep the industry abreast of the latest development of anti-money laundering regime in Hong Kong, the IA has organized several seminars on the subject matter since 1998.

As you are aware, the new Guidance Note on Prevention of Money Laundering and Terrorist Financing ("Guidance Note") will become effective on 1 July 2006. The regulatory requirements specified in the new Guidance Note are substantially strengthened, particularly in the areas of customer acceptance and customer due diligence. To facilitate the industry to better understand the Guidance Note and make necessary arrangements for compliance, the IA will conduct a seminar on the prevention of money laundering for insurers and insurance intermediaries on 22 March 2006 (Wednesday). The Commissioner for Narcotics, the Head of the Joint Financial Intelligence Unit and the IA will talk about the Guidance Note and other related issues. The programme of the seminar is attached at Annex A.

Prevention of money laundering and terrorist financing is a serious matter. You are therefore cordially invited to participate in the seminar together with your Finance Director, Compliance Officer, Training Managers, Agency Head and Agency Administrators. After attending the seminar, they are expected to train your company's insurance agents and other relevant staff

regarding measures to prevent money laundering and terrorist financing. Owing to the seating capacity, up to ten seats will be reserved for each insurer, although you may nominate more than ten persons. You will be informed nearer the time if additional seats are allocated to you.

For those participants who are subject to the Continuing Professional Development Programme under the Insurance Intermediaries Quality Assurance Scheme, they will be eligible to claim 2 CPD hours.
