United Nations Sanctions (Côte d'Ivoire) Regulation 2006, United Nations Sanctions (Democratic Republic of the Congo) Regulation 2005 & United Nations (Anti-Terrorism Measures) Ordinance

United Nations Sanctions (Côte d'Ivoire) Regulation 2006

In Hong Kong, a new piece of legislation – the United Nations Sanctions (Côte d'Ivoire) Regulation 2006 ("Regulation"), has recently been made under the United Nations Sanctions Ordinance. Pursuant to section 37 of the Regulation, a list of the "relevant persons and entities" has been specified for the purpose of paragraph 11 of the United Nations Security Council Resolution 1572. The Regulation and the list of the relevant persons and entities were published in the Gazette (L.N. 59 of 2006 and G.N. 1907) on 17 March 2006 and 24 March 2006 respectively, both of which are available on the Government website (www.gld.gov.hk/egazette/). To facilitate the update of your electronic database, a copy of the list in MS Word format is also available on the Insurance Authority's website (http://www.oci.gov.hk/framework/index04_03_06.html).

United Nations Sanctions (Democratic Republic of the Congo) Regulation 2005

Further to my letter of 5 January 2006, an updated list of the "relevant persons and entities" has been specified for the purpose of paragraph 15 of the United Nations Security Council Resolution 1596 under section 36 of the United

Nations Sanctions (Democratic Republic of the Congo) Regulation 2005. The list was published in the Gazette (G.N. 497) on 27 January 2006 which is available on the Government website (www.gld.gov.hk/egazette/). Compared with the names advised in my letter of 5 January 2006, the changes have been set out in Appendix.

You should review your records carefully to see whether you have had, or currently have, accounts, transactions or dealings with the named individuals or In addition, you are also encouraged to review your records against the entities designated as proliferators and supporters of weapons of mass destruction under United States Executive Order 13382. The name of the designated entities can be found the website ofthe US Treasury on (http://www.treas.gov/offices/enforcement/ofac/sdn). If such review reveals any suspicious accounts, transactions or dealings, you should promptly notify the Joint Financial Intelligence Unit.
