In Hong Kong, the United Nations Sanctions (Côte d'Ivoire) Regulation 2008 ("the Côte d'Ivoire Regulation 2008") was made under the United Nations Sanctions Ordinance (Cap. 537) and published in the Gazette (L.N. 16 of 2008) on 25 January 2008. It replaces the United Nations Sanctions (Côte d'Ivoire) Regulation 2007.
