Further to my letter of 24 January 2008, an updated list of terrorists and terrorist associates has been designated by the United Nations Security Council Committee ("Committee") specified under the United Nations (Anti-Terrorism Measures) Ordinance. The list was published in the Gazette (G.N. 1158) on 22 February 2008 which is available on the Government website (<u>www.gld.gov.hk/egazette/</u>). A copy of the list in MS Word format is also available on the Insurance Authority's website (<u>www.oci.gov.hk/framework/index04_03_08.html</u>).

Compared with the names advised in my letter of 24 January 2008, the changes have been set out in Appendix I. The relevant press releases issued by the Committee are also attached at Appendix II for your reference.
