United Nations (Anti-Terrorism Measures) Ordinance

Further to my letter of 16 January 2009, an updated list of terrorists and terrorist associates designated by the United Nations Security Council Committee ("Committee") has been specified under the United Nations (Anti-Terrorism Measures) Ordinance. The list was published in the Gazette (G.N. 1552) on 13 March 2009 which is available on the Government website (www.gld.gov.hk/egazette/). A copy of the list in Portable Document Format (pdf) is also available on the Insurance Authority's website (www.oci.gov.hk/framework/index04 03 09.html).

Compared with the last gazettal on 9 January 2009, the changes have been set out in Appendix I. The relevant press releases issued by the Committee are also attached at Appendix II for your reference.

United States Executive Order 13224

Further to my letter of 16 January 2009, the US Government has designated additional names to the list under the US Executive Order 13224.
