In Hong Kong, the United Nations Sanctions (Democratic Republic of the Congo) Regulation 2010 ("the Congo Regulation 2010") was made under the United Nations Sanctions Ordinance (Cap. 537) and published in the Gazette (L.N. 47 of 2010) on 30 April 2010. It implements sanctions against Democratic Republic of the Congo imposed by the Security Council in Resolution 1896 (2009).

A list of "relevant persons and entities" has been specified under section 30 of the Congo Regulation 2010 and was published in the Gazette (G.N. 2531) on 7 May 2010. The Congo Regulation 2010 and the list are available on the Government's website (<u>www.gld.gov.hk/egazette/</u>). A copy of the list in Portable Document Format (pdf) is also available on the Insurance Authority's website (<u>www.oci.gov.hk/framework/index04_03_10.html</u>).

United Nations Sanctions (Liberia) Regulation 2010

In Hong Kong, the United Nations Sanctions (Liberia) Regulation 2010 ("the Liberia Regulation 2010") was made under the United Nations Sanctions Ordinance (Cap. 537) and published in the Gazette (L.N. 48 of 2010) on 30 April 2010. It implements sanctions against Liberia imposed by the Security Council in Resolution 1903 (2009) and continues the implementation of the existing financial sanctions against Liberia under the Security Council in Resolution 1532 (2004).

A list of "relevant persons and entities" has been specified under section 31 of the Liberia Regulation 2010 and was published in the Gazette (G.N. 2532) on 7 May 2010. The Liberia Regulation 2010 and the list are available on the Government's website (www.gld.gov.hk/egazette/). A copy of the revised list in Portable Document Format (pdf) is available also on the Insurance Authority's website (www.oci.gov.hk/framework/index04 03 10.html).
