## United Nations Sanctions (Libya) Regulation 2011

Further to my letter of 30 December 2011, an updated list of relevant persons and entities has been specified under section 38 of the United Nations Sanctions (Libya) Regulation 2011 (Cap. 537 sub. leg. AW) ("the Libya Regulation"). The list was published in the Gazette (G.N. 286) on 20 January 2012 and is available on the Government's website (www.gld.gov.hk/egazette/).

I would like to draw your attention to section 7 of the Libya Regulation which prohibits making available funds or other financial assets or economic resources to relevant persons or entities, or dealing with funds or other financial assets or economic resources belonging to such persons or entities, except with a license.

You should review your records carefully to see whether you have had, or currently have, accounts, transactions or dealings with the named individuals or entities. If such review reveals any suspicious accounts, transactions or dealings, you should promptly notify the Joint Financial Intelligence Unit. You are also reminded to browse the US Treasury's website (including the FinCEN's website) regularly for the latest information.
