United Nations Sanctions (South Sudan) Regulation 2016 (i)

Further to the United Nations Sanctions (South Sudan) Regulation 2016 (Cap. 537 sub.leg. BU) ("the South Sudan Regulation") gazetted on 14 October 2016, a list of relevant persons has been specified under section 15 of the South Sudan Regulation. The list has been published in the Gazette (G.N. 5904) on 21 October 2016 and is available on the Government's website http://www.gld.gov.hk/egazette/.

We would like to draw your attention to section 2 of the South Sudan Regulation which stipulates that making available funds or other financial assets or economic resources to relevant persons or entities, or dealing with funds or other financial assets or economic resources belonging to such persons or entities are prohibited, except with a licence.
