## **United Nations Sanctions (Yemen) Regulation 2015 United Nations Sanctions (Central African Republic) Regulation 2017**

We are writing to inform you of the following developments:

(i) United Nations Sanctions (Yemen) Regulation 2015

An updated list of relevant persons has been specified under section 30B of the United Nations Sanctions (Yemen) Regulation 2015 (Cap. 537 sub. leg. BP) ("the Yemen Regulation"). The list has been published in the Gazette (G.N. 3173) on 19 May 2017 and is available on the Government's website http://www.gld.gov.hk/egazette/.

We would like to draw your attention to section 5B of the Yemen Regulation which stipulates that making available funds or other financial assets or economic resources to relevant persons or entities, or dealing with funds or other financial assets or economic resources belonging to such persons or entities are prohibited, except with a licence.
