Enhancing Market Transparency and Operational Efficiency

In keeping with our policy to enhance market transparency and operational efficiency, I write to inform you of two enhancement initiatives that will be launched by the Office of the Commissioner of Insurance ("OCI").

Enhancing Market Transparency

The OCI website provides a ready and effective means for members of the public to access updated and relevant information of the insurance industry. Apart from information on our insurance regulatory framework, the website also contains market statistics and information on individual insurers for easy access by the public, including the respective place of incorporation of the insurer and types of business authorized.

To enable easy contact by the public, we propose to include in our website information on the main business address in Hong Kong, its e-mail address, telephone number, fax number and official website address (with hyperlink) of all authorized insurers in Hong Kong. Apart from facilitating communication between the insuring public and the insurers, the listing of an insurer's website address would help improve security by providing a ready reference for the public to guard against fraudulent websites and related insurance frauds.
