## Signing of the Inter-governmental Agreement with the US to Facilitate the Implementation of US Foreign Account Tax Compliance Act ("FATCA")

Further to our circular letter dated 19 May 2014 regarding the discussions between the Hong Kong SAR Government and the United States ("US") on a Model 2 inter-governmental agreement ("IGA") that will facilitate compliance with the FATCA by financial institutions in Hong Kong, please note that the IGA was signed on 13 November 2014.

In this regard, a press release<sup>1</sup> was issued regarding the aforesaid. Hong Kong is now included in the list of jurisdictions that have signed Model 2 IGAs with the US and entitled to certain exemptions including simplified reporting and due diligence procedures to minimise the compliance requirements of financial institutions in Hong Kong. You may wish to refer to the signed Model 2 IGA provisions and Annexes I and II published at the website of the Financial Services and Treasury Bureau ("FSTB")<sup>2</sup> and contemplate all necessary actions to comply with the FATCA requirements and obligations including registration with the US Internal Revenue Service ("IRS") and meeting the due diligence and reporting obligations under the foreign financial institution agreement entered into by your institution with the US IRS.
