Subject: Recognized education proof (Update)

The Insurance Agents Registration Board (IARB) recently revisited the subject of "Recognized education proof", of which the related circular was issued on 25 January 2000 following the effective date of the Fourth Edition of the Code of Practice for the Administration of Insurance Agent in January 2000. Due to the change of examination system from Hong Kong Certificate of Education Examination (HKCEE) to Hong Kong Diploma of Secondary Education Examination (HKDSE) in 2012 and the variations in the standards of courses offered by different educational institutions, the IARB would like to update the captioned subject. Please refer to the attached sheet for the updates.

- ii. Form 5 graduation certificate; or

- iv. HKDSE result slip (any 3 or more subjects at level 2 or above): or 香港中學文憑考試成績通知 (任何 3 科或以上考獲 2 級或更高成績);或
- v. Proof of completion of the Diploma Yi Jin (DYJ) Program; or 完成毅進文憑課程的證明;或
- vi. Any other higher education proof. 任何更高學歷的證明文件。

2. Non-local education

 High school/ specialized qualification graduation certificate for Mainland China, to be supplemented by additional documents for authentication of the certificate stated in the circular "Enhanced Vetting Requirements for Registration" issued by IARB on 13 April 2017; or
