Dear Sir/Madam,

Statements issued by the Financial Action Task Force ("FATF")

Further to our letter of 11 March 2025, we are writing to inform you of the following developments:

- (1) <u>High-Risk Jurisdictions subject to a Call for Action</u>
 - (a) <u>Jurisdictions subject to a FATF call on its members and other jurisdictions to apply countermeasures The Democratic People's Republic of Korea ("DPRK") and Iran</u>

DPRK

The FATF remained concerned by the DPRK's continued failure to address the significant deficiencies in its anti-money laundering and counter-financing of terrorism ("AML/CFT") regime and the serious threats posed by the DPRK's illicit activities related to the proliferation of weapons of mass destruction and its financing.

DPRK has increased connectivity with the international financial system which raises proliferation financing risks. The FATF therefore calls for greater vigilance and renewed implementation and enforcement of countermeasures against the DPRK.

Iran

Given Iran's failure to enact the Palermo and Terrorist Financing Conventions in line with the FATF Standards, the FATF fully lifts the suspension of countermeasures and call on its members and urges all jurisdictions to apply

effective countermeasures, in line with Recommendation 19.

The FATF will remain concerned with the terrorist financing risk emanating from Iran and the threat this poses to the international financial system until Iran implements the measures required to address the deficiencies identified with respect to countering terrorism-financing in the Action Plan.

(b) <u>Jurisdiction subject to a FATF call on its members and other jurisdictions to apply enhanced due diligence measures proportionate to the risks arising from the jurisdiction – Myanmar</u>

The FATF urged Myanmar to work to fully address its AML/CFT deficiencies. Given the limited progress, it will remain on the list of countries subject to a call for action until its full action plan is completed. The call by the FATF on its members and other jurisdictions to apply enhanced due diligence measures proportionate to the risks arising from Myanmar in the October 2022 statement remains in effect. In this connection, IIs should apply enhanced due diligence measures, proportionate to the risks, to business relationships and transactions with natural and legal persons from Myanmar.

(2) Jurisdictions under Increased Monitoring

In addition, the FATF issued an updated statement on Jurisdictions under Increased Monitoring which can be found on the website of the FATF (https://www.fatf-gafi.org/content/fatf-gafi/en/publications/High-risk-and-other-monitored-jurisdictions/increased-monitoring-june-2025.html).

The statement sets out the list of jurisdictions that have committed to resolve swiftly strategic deficiencies in their regimes to counter money laundering, terrorist financing, and proliferation financing within agreed timeframes and are subject to increased monitoring. The FATF will closely monitor the progress made by these jurisdictions in addressing the identified strategic deficiencies and encourages its members to take into account the information presented in the statement in their risk analysis.

As the FATF will continue to assess the progress made by these jurisdictions in addressing the deficiencies in their AML/CFT systems and issue updated statements from time to time, IIs are reminded to browse the website of the FATF for the latest information.

(3) Other Outcomes from the Joint FATF-MONEYVAL Plenary, 12-13 June 2025

In addition to the statements in (1) and (2) above, the FATF also published various other outcomes of the recent Plenary jointly hosted by the FATF and

MONEYVAL which may be of interest to IIs, including the following: -

- (a) The FATF approved changes to Recommendation 16 of the FATF Standards that will improve detection of crimes and implementation of sanctions by increasing clarity on who is sending and receiving money in cross-border payments over 1000 USD/EUR. The FATF, meanwhile, published the revised Standards on 18 June 2025, and financial institutions will need to comply with the changes from 2030.
- (b) The FATF published an updated guideline on 23 June 2025 to empower financial institutions and other providers to boost financial inclusion. The new guidance equips practitioners and policy-makers with practical examples of how they can apply simplified measures where risks are assessed to be lower, including approaches to address de-risking, which occurs when financial institutions deny financial services to customers, rather than assessing and managing risks in line with the risk-based approach.
- (c) The FATF will soon publish a report examining complex proliferation financing and sanctions evasions schemes. This provides contemporary information for the private sector to implement its obligations to combat the proliferation of the financing of weapons of mass destruction.
