7B	<ul style="list-style-type: none">(a) 調查該投訴；(b) 向小組報告調查的結果及已採取的行動（如有者）； 或 <ul style="list-style-type: none">(c) 按小組規定採取紀律行動； <p>保險公司會被視為違反《守則》，而小組將會把事件交回委員會考慮。</p>
